# Electromagnetic compatibility (EMC) compliance

### Guidance and manufacturer's declaration

Special precautions concerning electromagnetic compatibility (EMC) must be taken for all medical electrical equipment.

- All medical electrical equipment must be installed and put into service in accordance with the EMC information provided in this document.
- Portable and mobile RF communications equipment can affect the behavior of medical electrical equipment.

The Acuity Central Station complies with all applicable and required standards for electromagnetic interference.

- It does not normally affect nearby equipment and devices.
- It is not normally affected by nearby equipment and devices.
- It is safe to operate it in the presence of high-frequency surgical equipment; however, it is good practice to avoid using the Acuity Central Station near other equipment.

#### **Electromagnetic emissions**

The Acuity Central Station is intended for use in the electromagnetic environment specified below. The customer or the user of the Acuity Central Station should assure that it is used in such an environment.



			where <b>P</b> is the maximum output power rating of the transmitter in watts according to the transmitter manufacturer and <b>d</b> is the recommended separation distance in meters.  Field strengths from fixed RF transmitters, as determined by an electromagnetic site survey <sup>a</sup> , should be less than the compliance level in each frequency range <sup>b</sup> .  Interference may occur in the vicinity of equipment marked with the following symbol:

Note 2 These guidelines may not apply in all situations. Electromagnetic propagation is affected by absorption and reflection from structures, objects and people.

- Field strengths from fixed transmitters, such as base stations for radio (cellular/cordless) telephones and land mobile radios, amateur radio, AM and FM radio broadcast and TV broadcast cannot be predicted theoretically with accuracy. To assess the electromagnetic environment due to fixed RF transmitters, an electromagnetic site survey should be considered. If the measured field strength in the location in which the Acuity Central Station is used exceeds the applicable RF compliance level above, the Acuity Central Station should be observed to verify normal operation. If abnormal performance is observed, additional measures may be necessary, such as reorienting or relocating the Acuity Central Station.
- b Over the frequency range 150 kHz to 80 MHz, field strengths should be less than 3 V/m.

## Recommended separation distances between portable and mobile RF communications equipment and the Acuity Central Station

The Acuity Central Station is intended for use in an electromagnetic environment in which radiated RF disturbances are controlled. The customer or the user of the Acuity Central Station can help prevent electromagnetic interference by maintaining a minimum distance between portable and mobile RF communications equipment (transmitters) and the Acuity Central Station as recommended below, according to the maximum output power of the communications equipment.

For transmitters rated at a maximum output power not listed above, the recommended separation distance *d* in meters (m) can be estimated using the equation applicable to the frequency of the transmitter, where *P* is the maximum output power rating of the transmitter in watts (w) according to the transmitter manufacturer.

NOTE 1 At 80 MHz and 800 MHz, the separation distance for the higher frequency range applies.
